THE POST OF FACULTY/ASSOCIATE FACULTY MEMBER (ON CONTRACT)

IIIT Una (Saloh) is one of the 20 IIITs being setup, funded, and managed by the Ministry of Education, Govt. of India under the Public Private Partnership (PPP) model. The partners of IIIT Una (Saloh) are the Ministry of Education, Govt. of India, the Govt. of Himachal Pradesh, HP Power Corporation Limited, and HP Transmission Corporation Limited. Admissions to the undergraduate programs in the Institute are made through the Joint Entrance Examination (JEE).

Applications are invited from enthusiastic and dynamic nationals with excellent and consistent academic record from Secondary School to PhD for the post of Faculty Member (On Contract)/ Associate Faculty Member (On Contract) on temporary basis purely for a fixed duration, in the following discipline, as per the tentative vacancies listed:

- I. Consolidated Remuneration :** (a) For Ph.D. holders – Rs.90,000/- per month.
(b) For Master Degree holders – Rs.60,000/- per month.

iii) The shortlisted candidate for interview and the interview schedule will be displayed on our website.

The last date for submission on **05, Aug.'26**. The candidate must submit a set of copies of all relevant documents (self-attested), at the time of joining the institute, if selected.

III. General terms and conditions:

- The nature of appointment is purely a stop gap arrangement on temporary basis for maximum one academic year, i.e., AY 2026-27 with a provision of termination of services within one month of joining of regular faculty member or any further order in this regard, whichever is earlier.
- All applications received shall be scrutinized by a duly constituted Screening Committee.
- The prescribed Essential Qualification/Experience indicated are bare minimum and mere possession of same will not entitle the candidate to be called for interview. IIIT Una may restrict the number of candidates to be called for interview to a reasonable limit based on qualification and experience higher than that of the minimum prescribed in the advertisement. The decision of the Screening Committee shall be final in this regard.
- Institute also reserves the right to adopt any other additional shortlisting criteria over and above the advertised criteria to restrict the candidate for the selection process.
- IIIT Una is an Institute of National Importance and accordingly for faculty positions, institute looks forward towards the candidates with high academic credentials, who are motivated and suited for academic positions at INIs. Therefore, you must satisfy your suitability for the position commensurate to the standard of INIs before applying.
- The Faculty/Associate Faculty member (On contract) may resign from the post during the contract period after serving one month notice period or one month salary in lieu of that and similarly Institute may also terminate the services of faculty member by giving one month notice or one month salary in lieu of that without assigning any reason.
- Original documents of age proof/degrees/mark sheets/experience must be presented at the time of interview.
- The most recent three journal (refereed and SCI/SCIE/SCOPUS Indexed) publications may be combined as a single pdf and kept ready before filling up of application form.
- Applicants in employment (private, government or any other organization) are required to submit a "No Objection Certificate" from the employer at the time of interview.
- No TA/DA will be paid for attending the interview.
- The selected candidates will be required to join immediately within one week of receiving of the offer letter.
- Canvassing in any form will render a candidate ineligible.
- Institute reserves the right to select or reject a candidate without assigning any reason/s thereof.
- This post does not confer any right on the applicant to claim either continuous employment or permanency in future.
- The institute reserves the right to defer or cancel the advertisement at any stage of processing without assigning any reasons, if required.
