I. HOW TO APPLY

1. The eligible and interested candidates are required to apply online. The application link for the online portal is available on institute website <https://iiitu.ac.in/recruitment>. Applications received through any other mode such as emails, posts, etc. shall not be accepted and summarily rejected. Every completed online application shall be identified by a unique application id.
2. Candidates are directed to note down and remember the unique application id which will be used to identify a candidate for Written Test and/or Presentation/Interview.
No correspondences/enquiry for lost application id will be entertained.
3. Applications which are not submitted online and not uploaded with relevant supporting documents shall be summarily rejected.
4. Last date for submission of online application is **04, Jul.'26**. All educational and other qualifications/Experiences etc. will be considered as on the last date of the online submission of application form, i.e., **04, Jul.'26 upto 23:59 hrs.**
5. If a candidate wants to be considered for more than one Post then candidate has to submit only one application form by choosing multiple positions in online application portal. Please check your eligibility carefully before applying for various positions.
6. Problem encountered, if any, during online filling/submission of application form may be

immediately brought to the notice of the Institute, during office hours, through the following channels:

7. Candidates are advised in their own interest **to submit online applications much before the closing date** and not to wait till the last date to avoid the possibility of disconnection/inability or failure to login to the website on account of heavy load on the website during the closing days. Applications received after expiry of the last date, time will not be entertained, and the Institute will not be responsible for any delay.

II. PROCESS OF RECRUITMENT FOR FACULTY POSITIONS

A. Assistant Professor (Grade I)/ Associate Professor / Professor

The recruitment process for the posts of **Assistant Professor (Grade I), Associate Professor, and Professor** shall ordinarily comprise the following stages:

1. **Stage I – Screening**
2. **Stage II – Departmental Presentation**
3. **Stage III – Presentation-cum-Interview**

Stage I – Screening

1. All applications received against the advertisement shall be scrutinized by a **duly constituted Screening Committee** to verify the prescribed educational qualifications, experience requirements, and other eligibility conditions.
2. A **Credit Points (CP) score** as attached in Annexure-I shall be prepared as prescribed in the **Faculty Recruitment Rules of IIIT Una**, available on the Institute website. Please note it is mandatory to attain the minimum Credit Point Score which is minimum eligibility in addition to the required minimum qualification and experience.
3. In addition, a **Research & Academic Score (RAS), as attached** in Annexure-II shall be prepared by the Screening Committee based on:
 - o academic credentials,
 - o quality and impact of research publications,
 - o sponsored and completed research projects,
 - o patents and technology transfer,
 - o evidence of independent high-quality research,
 - o awards, recognitions, and fellowships, and
 - o any other relevant scholarly achievements.
4. Required experience should be post PhD and at the appropriate level (both designation as well as Level as per 7th CPC or equivalent) preferably from institutions of national importance, institutions which are funded by the Central/State Govt, NIRF 100 ranked. Appropriate documents with details of positions held with pay level/pay scale etc should be mentioned. Please note, in case of private institutions, the consolidated salary drawn should

- be commensurate to the salaries drawn in central/state government funded institutions at the corresponding level/pay scale.
5. Post-doctoral experience shall be counted as research experience from reputed institutions and with fellowship which is at par with the national standards.
 6. **Please note that the decision of the screening committee regarding consideration of the claimed experience shall be final.**
 7. Mere fulfilment of the **minimum eligibility criteria shall not entitle a candidate to be called for Stage II**. Candidates are therefore advised to furnish complete details of all credentials along with documentary evidence.
 8. In case any clarification, discrepancy, or shortfall in documents is noticed, the candidate shall be informed through the **Online recruitment portal** as well as the registered email address. Such candidates shall be provided **48 hours** to submit the required clarification and supporting documents through the portal. The Screening Committee shall re-examine the submitted clarification/documents and take an appropriate decision regarding eligibility and scoring.
 9. The Screening Committee shall have the right to make **qualitative assessment and normalization, wherever required, in the evaluation of CP and RAS parameters**, and its decision in this regard shall be **final and binding**.
 10. Based on the **cumulative screening score comprising over and above the minimum requirement of CP and RAS**, candidates shall be shortlisted for **Stage II – Departmental Presentation**. The shortlisting Committee of the Institute may adopt any other shortlisting criteria to restrict the number of candidates to be called for interview/written test/trade test/skill test (as the case may be) to a reasonable number.
 11. The number of candidates called for the interview shall be strictly based upon merit and will be commensurate to the number of positions available. Please note that due to flexi cadre of faculty structure the number of vacancies may increase or decrease at the time of final selection.
 12. The **CP score, RAS, and cumulative screening score [CP (over and above the minimum requirement) + RAS]**, along with the list of candidates shortlisted for Stage II, shall be displayed on the Institute website.
 13. Thereafter, the application status shall be notified as:
 - **Shortlisted List for Stage II/III after submission and verification of documents (PSL)**
 - **Not Shortlisted List (NSL)**
 14. The status shall be updated on the recruitment portal and also communicated to the candidates through their registered email addresses.
 15. All candidates placed under the **PSL** shall be invited for **Stage II – Departmental Presentation**.

Stage II – Departmental Presentation

16. All **PSL candidates** shall be invited to appear in the departmental presentation at the **IIT Una campus**, subject to successful **document verification** by a duly constituted **Document Verification Committee**.

17. Candidates must produce **all original documents** along with **two sets of self-attested photocopies**. Failure to produce the required documents, or any discrepancy between the original documents and the claims made in the online application, may lead to **disqualification from the departmental presentation and the subsequent recruitment process**.
18. Candidates shall also be required to submit a **signed PDF copy of the online application form** at the time of document verification.
19. Only those candidates whose documents are successfully verified shall be permitted to appear in the **departmental presentation** at IIT Una.
20. Candidates shortlisted for Stage II shall be required to make a presentation on their research contributions, future research agenda, teaching plans, and academic vision before the faculty members of the concerned School/Department.
21. This stage shall be non-eliminating in nature and intended to assess:
 - depth of subject knowledge,
 - teaching aptitude,
 - research vision,
 - communication skills,
 - academic leadership potential
 - presentation ability.
22. Appearing for presentation at this stage shall be mandatory for appearing in **Stage III**.
23. One or more External Referees/Experts may be appointed to provide an independent report regarding the suitability of the candidates. .
24. This will be a non-eliminating round but essential to move to **STAGE-III**

Stage III – Presentation-cum-Interview

25. All candidates from Stage II shall appear before a **duly constituted Selection Committee** for the final presentation-cum-interview.
26. The final merit list of recommended candidate(s) shall be prepared on the basis of the following weightage criteria:

27. The **Selection Committee reserves the right not to recommend any candidate** if none is found suitable for the post.
28. A **panel/waiting list** may also be prepared, wherever considered necessary, in case the number of suitable candidates exceeds the notified vacancies.
29. The recommendations of the Selection Committee shall be placed before the **Competent Authority/Board, as applicable under the Statutes of the Institute**, for approval.
30. The decision of the Competent Authority shall be final and binding.

B. Assistant Professor (Grade II)

The recruitment process for the posts of **Assistant Professor (Grade II)** shall ordinarily comprise the following stages:

1. **Stage I – Screening**
2. **Stage II – Written Test**
3. **Stage III – Presentation-cum-Interview**

Stage I – Screening

1. All applications received shall be scrutinized by a **duly constituted Screening Committee** to verify the **minimum eligibility criteria**.
2. A **Research Academic Score (RAS)** as attached shall be prepared based on the candidate's **academic credentials, awards, research accomplishments, and other relevant achievements**.
3. In case of any clarification required by the screening committee or shortfall in documents, candidates shall be informed through the **Online recruitment portal** as well as their **registered email address**. Such candidates shall be given **48 hours** to submit the required clarification/supporting documents through the portal.
4. The Screening Committee shall re-examine the submitted explanations/documents and take an appropriate decision.
5. Thereafter, the decision of the Committee shall be final, and the list of applicants shall be published as:
 - **Shortlisted for Written Test after submission and verification of documents (PSL)**
 - **Not Shortlisted (NSL)**

The status shall be updated on the recruitment portal and also communicated to the candidates through their registered email addresses.

6. All candidates meeting the minimum eligibility criteria and placed under **PSL** shall be invited for **Stage II**.

Stage II – Written Test

7. All **PSL candidates** shall be invited to appear in the written test at the **IIIT Una campus**, subject to successful **document verification** by a duly constituted **Document Verification Committee**.
8. Candidates must produce **all original documents** along with **two sets of self-attested photocopies**. Failure to produce the required documents, or any discrepancy between the original documents and the claims made in the online application, may lead to **disqualification from the written test and the subsequent recruitment process**.
9. Candidates shall also be required to submit a **signed PDF copy of the online application form** at the time of document verification.
10. Only those candidates whose documents are successfully verified shall be permitted to appear in the **written test**, which shall be conducted in **offline physical mode** at IIIT Una.
11. The written test shall be of **two hours’ duration**, consisting of **multiple-choice questions (MCQs)**. Negative marking may be provisioned for wrong answers.
12. Candidates will be shortlisted for **Stage-III** based upon the following criteria:

Cut Off Marks:

All Other: 40%

Candidates securing cut off or above marks shall be invited for a presentation-cum-interview at **STAGE-III**

13. The list of candidates shortlisted for **Stage III**, shall be displayed on the Notice Board of the institute
14. Candidates **not qualifying** for **Stage III** may leave thereafter.

Stage III – Presentation-cum-Interview

15. All candidates qualifying Stage III shall appear before a **duly constituted Selection Committee** for the **final presentation-cum-interview**. Presentation shall be on their research accomplishments, future research plans, teaching
16. The final merit list shall be prepared on the basis of the following **weightage criteria**:

III. GENERAL INSTRUCTIONS/ INFORMATION TO CANDIDATES

1. The candidates should read carefully the requisite minimum essential qualifications, age and eligibility, experience criteria etc. laid down in the advertisement before applying for these posts. Since all the applications will be screened on the basis of data submitted by the candidate in the online application form, the candidates must satisfy themselves of the suitability for the position to which they are applying. If at any stage during the recruitment and selection process, it is found that candidates have furnished false or wrong information, their candidature will be rejected.
2. IIIT Una is an institute of national importance and accordingly for faculty positions, institute looks forward towards the candidates with high academic credentials, who are motivated and suited for academic positions at INIs. Therefore, you must satisfy your suitability for the position commensurate to the standard of INIs before applying.
3. Application once submitted cannot be altered / resubmitted, under any circumstances. Further, no request with respect to making changes in any data/ particular entered by the candidate in the Online Application will be entertained, once the application is submitted successfully. Therefore, please keep all data/ details ready before you start filling up the Application Online.
4. The candidates are required to apply **ONLINE** only from **25, May'26 to 04, Jul.'26** upto **23:59 hrs.** For submission of application, please visit recruitment portal <https://iiitu.ac.in/recruitment>. Application will NOT be accepted through any other mode.
5. The candidate may fill single online application form for multiple position by choosing different positions. However, the payable fee shall be computed for each position separately.
6. The candidate must be a citizen of India.
7. Relaxation of Age
 - a. The maximum prescribed age for each post shall be the same as given against each post in the Recruitment Rules of the Institute. The age shall be determined as on the last date of the advertisement.
 - b. Age relaxation as per applicable Govt. of India norms shall be applicable.
8. Candidates should submit self-attested photocopies of required certificates and other documents, in support of their claims in the application such as age, community such as SC/ST/OBC/EWS/PwD etc. (in the prescribed format), educational qualifications, experiences, etc.
